

**Budget Amendment**



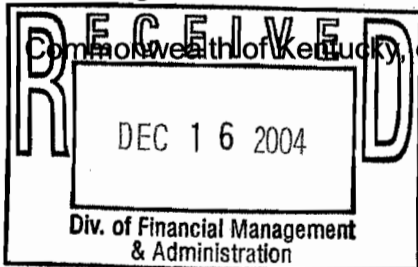
