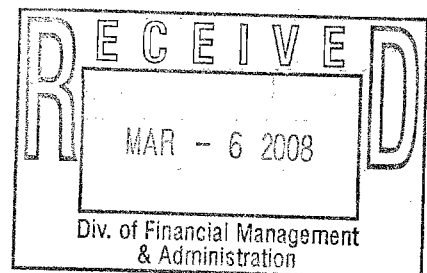
Section One: The budget for Fiscal Year 2007-2008 is amended to:




