At a regular meeting of the Simpson County Fiscal Court held in the Fiscal Court Meeting Room in the Simpson County Historic Courthouse, May 16, 2017, at 8:30

Present: Honorable Jim Henderson, Judge/Executive Honorable Bobby Bush, Magistrate Honorable Marty Chandler, Magistrate Honorable Larry Randolph, Magistrate Honorable Blake Tarpley, Magistrate Honorable Sam Phillips, County Attorney Meghann Bush, Treasurer Nicole Law, Finance Officer Pam Rohrs, Fiscal Court Clerk

Judge Henderson called the meeting to order and led in prayer followed by the pledge of allegiance to the American flag.

Pursuant to KRS 42.455 and KRS 174.100, Judge Henderson officially opened the public hearing, as advertised, for the County Road Aid (CRA) and Local Government Economic Assistance (LGEA) for public comment regarding use of these restricted funds. The projection of CRA funds from the motor fuels taxes for the FY17-18 is \$786,565 and \$110,000 from LGEA funds from taxes levied on minerals mined in our county, mostly crushed stone. There was no one present from the public to offer comment on the use of these funds and Judge Henderson closed the hearing.

Fiscal Court engaged in discussion in follow-up to the presentation of the FY17-18 Budget at the May 2<sup>nd</sup> meeting. \$200,000 will be added to the budget to provide help with improvements to the community park. Fiscal Court would like to have input into the use of this significant contribution and Magistrates Randolph and Tarpley as well as Facilities Maintenance Supervisor Bill Rohrs will serve on a committee to work with the park as a plan is developed for the needed renovations. Magistrate Randolph will invite City Commissioner Jamie Powell to join this committee as Fiscal Court hopes that the city will be involved and contribute to the much needed improvements at the park as well. Additional funds will be added to the budget for soil conservation. Provision for additional property acquisition will be added as previously discussed by the court. Magistrate Tarpley presented the employee health insurance plans for FY17-18 during this discussion.
