

ORDINANCE NO. 220.109

COMMONWEALTH OF KENTUCKY  
SIMPSON COUNTY FISCAL COURT

**AN ORDINANCE RELATING TO THE COLLECTION AND DISPOSITION  
OF FEES BY AND PAYMENT OF COSTS OF THE OFFICE OF THE  
SHERIFF OF SIMPSON COUNTY, KENTUCKY**

BE IT ORDAINED by the Fiscal Court of the County of Simpson, Commonwealth of Kentucky, after the passage, approval and publication of this ordinance, as follows:

1. Effective from and after March 1, 2005, all net income and net fees from the Office of the Sheriff of Simpson County, Kentucky, shall be paid over to the County Treasurer, such payment to be on a monthly basis and not later than the 10<sup>th</sup> day of each month for the net income and net fees collected in the preceding month.

2. "NET INCOME" and "NET FEES" shall mean all unexpended income and all unexpended fees collected since January 1, 2005 less only applicable refunds to customers.

3. The expenses of and the expenditures by the Office of the Sheriff of Simpson County, Kentucky shall be pre-approved and paid by the County Treasurer in accordance with the Purchase Order system adopted by the Simpson County Fiscal Court. Provided however; the Sheriff shall certify to the Treasurer for payment each pay period, the names and hours of each employee of his or her office who worked during such pay period and the Treasurer shall pay such payroll without the necessity of any Purchase Order.

4. The Sheriff shall draw no checks upon the Fee Account other than the check to pay over the net income and net fees of the Fee Account to the County Treasurer.

- 5. The Sheriff shall be compensated at the maximum rate permitted by law.
- 6. This Ordinance shall become effective March 1, 2005.
- 7. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions hereof. All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.




